Sandro Galea, a physician, epidemiologist, and author, is dean and Robert A. Knox Professor at Boston University School of Public Health. He previously held academic and leadership positions at Columbia University, the University of Michigan, and the New York Academy of Medicine. He has published extensively in the peer-reviewed literature, and is a regular contributor to a range of public media, about the social causes of health, mental health, and the consequences of trauma. 

Learning Community in Trauma-Responsive Services for Human Service Providers



Eight 1.0 hour Live Webinars 11/19, 12/3, 1/7, 1/21, 2/4, 2/18, 3/4, 3/25 12:00 pm-1:00 pm Live Webinar via ZOOM

Description: Participants will gain a deep appreciation of the prevalence of trauma in our communities, as exemplified by the Adverse Childhood Experiences (ACEs) study, and will explore how traumatic (or adverse) experiences are inextricably intertwined with mental health problems, substance use disorders, and issues with caregiving. The series prepares professionals to: 1) develop a plan to address ACEs through screening/assessment, 2) use the "trauma-responsive framework" to intervene in a trauma-informed manner, and 3) create a pilot project to kick-start initiatives in their own settings.

Foundational Training in Trauma-Responsive Systems

Eight 60-minute live video conference learning sessions on the foundations of trauma-informed care (TIC)

- 1. Examine "Trauma theory" and the fundamentals of social neuroscience Adverse Childhood Experiences (ACE) study and the prevalence of traumatic exposure
- 2. Review systemic oppression and social determinants of health
- 3. Describe disrupted neurodevelopment (the role of adversity & relationships)
- 4. Identify functional impairments associated with traumatic exposure
- 5. Discuss complex trauma and misdiagnosis
- 6. Recognize adverse experiences in human services involvement
- 7. Explain Principles and practices associated with the TIC approaches
- 8. Review assessment & intervention techniques for trauma

Expert Consultation in Trauma-Responsive Systems

Each of the eight 60-minute live video conference learning sessions on the foundations of trauma-informed care (TIC) will support participant efforts to develop their own pilot projects in TIC and will include practice opportunities to hone their skills in TIC. Participants will have access to current resources in TIC to supplement the training sessions.

Target Audience: This workshop is an advanced professional development opportunity for professionals seeking to become "trauma competent" and to develop trauma-informed systems of care in their own agencies/organizations.

Cassie Yackley, Psy.D., P.L.L.C -Dr. Yackley has worked in the field of mental health with a specialty focus on trauma and child maltreatment. She provided psychotherapy to traumatized youth and families for nearly 25 years and directed an APA-accredited doctoral internship training program for a decade, before shifting fully to a training and consultation role in trauma-informed care systems transformation. As the administrative director of a multi-year statewide implementation project aimed at creating a trauma-informed child welfare system, Dr. Yackley trained all child protection and juvenile justice professionals throughout NH in screening and referrals for trauma impacted youth. She developed a training curriculum in trauma-informed early childhood services (TIECS) that has been used to train at least a thousand early childhood providers. In her efforts to create trauma-responsive systems, Dr. Yackley has been fortunate to collaborate with a broad range of providers through New England, including: schools, police departments, mental health agencies, psychiatric hospitals, home visiting programs, child care centers, child advocacy centers, homeless shelters, and residential treatment facilities.

Join us in using an evidence based framework, Arts and Culture in Public Health, to identify mechanisms you can use for yourself and your patients to increase engagement, strengthen communication, and create positive health outcomes.

Creating mandalas, provide a non-threatening approach for health professionals to support the clients they serve. Mandalas can be used as a form of art therapy or as a creative expression and can reduce anxiety, tension, stress, and increase focus. Originating in ancient Asian religions, the mandala is recognized by patterns of geometric, concentric circles and used as an aid in meditation. The psychological underpinning for this form of expression is Jungian.

Creating mandalas is fun, and it can be used to stimulate awareness, self-expression, and communication with others; and to create a mechanism to diffuse and manage stress.

Learning Objectives

- Describe the history and the process for creation of a mandala.
- Explain the psychological basis for mandala usage.
- Implement a mandala creation as a personal expression.
- Discuss mandala usage in a variety of settings.

Stress can take a toll on us all, especially in uncertain times. It is easy to forget that our own self-care is essential to our wellbeing. If we are depleting ourselves, we ultimately have less energy to give to our work or to offer someone else. Over time we can develop stress overload called "compassion fatigue," a set of symptoms that can affect our health, emotions, thoughts, relationships, behaviors, and even how we feel about the world in general.

In this workshop we will learn and practice some tools that we can use, giving us a sense of control and allowing us to let go of things beyond our control.

Learning Objectives

- Describe the stressors and signs of stress (healthy stress, compassion fatigue, burn-out)
- Recognize the link between thoughts, behavior, and emotion.
